

## 2022 Moots Cycles Giveaway Rules

### Complete Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PRODUCT PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. INTERNET ACCESS AND EITHER AN EMAIL OR INSTAGRAM ACCOUNT ARE REQUIRED TO ENTER.

**ELIGIBILITY:** The 2022 Moots Cycles Giveaway Rules (“Promotion”) is offered and open only to legal residents of the 50 United States and D.C. who are 18 or older at time of entry. Void in all other territories and locations where prohibited. Employees, officers and directors of Moots Cycles (“Sponsor”), and those entities involved in the preparation of materials and/or administration of this Promotion, including any retailer at which this Promotion is advertised or promoted (collectively referred to herein as the “Promotion Entities”), and their immediate family members (spouse, siblings, children and parents) and those living in the same household as such individuals (whether or not related) are not eligible to enter.

Bonus entries will be counted from public Instagram accounts that tag a valid Instagram account in the comments section of each giveaway post during the promotion period. All entries become the property of Sponsor and will not be returned. Promotion Entities assume no responsibility for lost, late, incomplete, inaccurate, stolen, misdirected, postage due or illegible entries; nor for any computer, telephone, cable network, electronic or Internet hardware or software malfunctions, failures, connections, or availability, or garbled, corrupt, or jumbled transmissions; nor service provider, Internet, Web site, user net accessibility or availability, traffic congestion, or any technical error; nor for unauthorized human intervention, human error, or the incorrect or inaccurate capture of entry or other information; nor for the failure to capture any such information.

The potential winner will be contacted by direct message on Instagram at the account provided at the time of entry within 5 to 10 business days after the drawing. Sponsor will make one attempt to notify each potential winner, who will have twenty-four (24) hours to respond.
